# **Examples of Statewide Age-Friendly Initiatives**

#### Introduction

As states are investigating how to best support growing populations of older adults, statewide age-friendly initiatives are becoming increasingly common. These initiatives, including policies, programs, and strategies, are aimed at improving access to health care, long-term services and supports, and social, economic, and environmental resources in order to support the health, wellbeing, and independence of all residents.¹ Notably, statewide initiatives are able to promote more efficient, coordinated, and equitable use of resources.¹-3 For rural communities, this is of critical concern as they are home to a greater share of older adults than urban communities, and funding, workforce, and general resources for aging supports is often more limited or fragmented.²-4,5

# **Purpose**

The purpose of this guide is to provide examples of statewide and rural-focused initiatives that support aging in place for older adults. A complementary policy brief, <u>Statewide Age-Friendly Initiatives: An Environmental Scan</u>, 6 identified 33 age-friendly initiatives across 22 states, six of which included an explicit rural focus. This guide provides an overview of those initiatives.

# **Approach**

To identify statewide age-friendly initiatives, the research team conducted an environmental scan using Google. Search terms included the state name, either "aging in place" or "age friendly" (policies, programs, or strategies that support the health, wellbeing, and independence of all people as they age), and the Boolean operator "AND" (e.g., "Arizona AND 'aging in place" or "Arizona AND 'age friendly"). This was replicated for each of the 50 U.S. states. Each statewide initiative that we discovered was documented in Excel. Additionally, we searched each initiative's website to identify any explicit rural focus. This was done by reviewing the website's navigation bar as well as using the website's internal search bar or the Control+F function to find any mentions of "rural." These findings were documented in Excel with a description and related focus areas.

# Statewide Aging in Place Initiatives

The initiatives in this guide are not meant to be an exhaustive list, but rather are intended to provide examples of the scope of initiatives, and in particular, initiatives that include a rural focus. Additionally, the degree to which these programs are currently active varies. However, the range of initiatives serves to provide ideas of what is possible and how various states are approaching age-friendly strategies. The following tables provide a short description of each initiative, along with the main focus areas and where to access more information.



# **Examples of Statewide Age-Friendly Initiatives**

#### **Nationwide Initiatives**

These initiatives represent examples of organizations that have national networks to support states as they implement age-friendly strategies, policies, and programs. The provided descriptions reflect the overall network although participating states likely have unique strategies in place.
